

## **CANAL CASH TERMS & CONDITIONS**

Canal Cash is processed as a promotion.  
It may not be combined in conjunction with any  
other discount, promotion, special offer or discounted check.

### **EARNING CANAL CASH**

- Canal Cash is accrued at a rate of 10% for every Net \$1.00 spent on Food and Beverage, excluding tax, gratuity and discounts while dining in our Restaurant or Patio.
- Canal Cash cannot be earned in conjunction with Canal Cash redemption.
- Canal Cash cannot be earned on any discounted check, special offer, promotion or banquet.
- Canal Cash is earned while ordering from lunch and dinner menus only.
- Not valid with promotional and holiday menus.
- Canal Cash cannot be earned on Gift Certificate purchases, to-go orders, catering, banquets, special events, Mother's Day, Easter, Thanksgiving, Christmas Eve, Christmas Day and New Year's Eve.
- Maximum Canal Cash earned on any single occasion is \$50.
- Present your Account # (Primary Phone#) at the time of dining to earn Canal Cash.
- Canal Cash will post to your account within 24 hours.
- Only the member paying the bill may accrue Canal Cash.
- Canal Cash issued on dollar amount paid with cash, check or credit card.
- Canal Cash cannot be accrued when paying by gift card or charged to a house account.

- Members cannot accrue credit on purchases made prior to their enrollment of the Canal Club Program.

### **REDEEMING CANAL CASH**

- Maximum Canal Cash redeemed on any single occasion is \$25.
- Canal Cash cannot be redeemed on holidays, banquets or any special event.
- Canal Cash cannot be applied to any discounted check, special offer or promotion.
- Canal Cash is not valid for tax or gratuity. Tax liabilities are the responsibilities of the Canal Club Member.
- Canal Cash has no cash value and may not be redeemed for Cash.
- Canal Cash cannot be used to purchase gift certificates.
- Canal Cash is non-transferable or devisable and may not be combined and/or redeemed with other member's accounts.
- Canal Club Accounts with more than 1 year of transaction inactivity may forfeit their Canal Cash without advance notice.

### **ADMINISTRATION**

- Canal Cash rebate program, percentage amount, rules and membership subject to change and/or termination at any time of the sole discretion of PLR Management.
- Not responsible for computer, technical, administrative or other errors.
